- Recruitment options
- Apprenticeship for existing members of staff





WHATS NEXT

The next step in the employer process, is for ITeC Digital Training to complete a Health and Safety appraisal which is valid for 4 years.

The H&S appraisal is in two parts:

Section 1 - Management of H&S - checking policies and procedures e.g:

- Public and employers liability details
- Health & safety policy
- Risk assessments including COVID-19
- Fire management details
- First aid

Section 2 - Workplace Visit

* During the COVID-19 lock down period a video of the premises, fire exits, etc would be acceptable.

EMPLOYER CHECKLIST

Once the H&S appraisal is the in progress you will be contacted by our compliance team who will discuss what it required of you prior to the apprentice starting.

This will include the following:

- Digital sign up platform (Smart Assessor)
- Apprentices contract of employment
- Employers privacy notice
- ☐ Health & Safety contract
- ECO code
- Employer incentive
